BUDGET HEARING AND ANNUAL MEETING AND ELECTION ELDRED CENTRAL SCHOOL DISTRICT

NOTICE IS HEREBY GIVEN that the Board of Education of the Eldred Central School District will hold a Budget Hearing at the George Ross Mackenzie Elementary, 1045 Proctor Road, Glen Spey, New York, in said district on Thursday, May 3rd, 2018 at 7:00 pm (Prevailing time) for the purpose of discussion of the expenditure of funds and the budgeting thereof proposed by the Board of Education for the school year July 1, 2018 – June 30, 2019.

NOTICE IS GIVEN pursuant to Section 1716 of the Education Law, that a copy of the statement of the amount of money, which may be required for the following year for school purposes, exclusive of public money, and the Real Property Tax Exemption Report will be annexed to any budget of which it forms a part and may be obtained by any resident in the District at the District Office, 600 State Route 55, Eldred, New York, and at each of the two following school buildings in the District: The George Ross Mackenzie Elementary School, Glen Spey, NY, and the Eldred Junior/Senior High School Grades 7-12, Eldred, NY, during the fourteen days immediately preceding the annual budget vote and election, between the hours of 8:00 a.m. and 2:00 p.m. prevailing time, other than a Saturday (by appointment only), Sunday, or a holiday, together with the text of any resolution to be presented to the voters and will be available on the District website. A copy of the detailed statement of estimated expenditures will also be made available at the Budget Hearing to be held **May 3rd, 2018**.

NOTICE IS GIVEN that the Annual Vote upon the appropriation of the necessary funds to meet the estimated expenditures for school purposes for the 2018-19 school year and the election of members of the Board of Education and any other business that may legally come before this meeting will take place on May 15, 2018, between the hours of 11:00 am and 9:00 pm prevailing time, at the Eldred Junior/Senior High School, 600 State Route 55, Eldred, New York

NOTICE IS GIVEN: that the following persons have submitted nominating petitions to fill one five-year term on the Board of Education effective July 1, 2018 and expiring on June 30, 2023, vacated by the expired terms of Linda Bohs.

NOTICE IS GIVEN that the following proposition will appear on the ballot:

PROPOSITION NO. 1

Shall the following resolution be approved?

The annual budget of the Eldred Central School District for the fiscal year 2018-2019 is hereby adopted and the requisite portion thereof to be raised by taxation on the taxable property of the

School District is hereby authorized to expend during the 2018-2019 school year \$16,848,150.00 and to levy the necessary tax thereof.

RESOLVED: that the Board of Education of the Eldred Central School District, Sullivan County, be authorized to make the expenditures shown in the budget presented by the Board of Education for the 2018-19 school year.

PROPOSITION NO. 2

Shall the following resolution be approved?

That the Board of Education of the Eldred Central School District is hereby authorized to levy taxes annually in the amount of \$14,790.00 and to pay over such monies to the Board of Trustees of the Sunshine Hall Free Library.

RESOLVED: that the Board of Education of the Eldred Central School District, Sullivan County, be authorized to make the expenditures shown in the budget presented by the Board of Education for the 2018-19 school year.

NOTICE IS GIVEN that pursuant to section 2014 of the Education Law, Personal Registration of voters is required, and no person shall be entitled to vote at the Annual Meeting and Election to be held on May 15, 2018, whose name does not appear on the register of the District or who does not register as hereinafter provided, except a person who is otherwise qualified to vote and is registered under the provisions of Article 5 of the Election Law. The times and place of registration are set forth below, and any person shall be entitled to have that person's name placed upon such register, that person is known or proven to the satisfaction of personally registering, to be then or thereafter entitled to vote at the school meeting or election for which such register is prepared.

The District Clerk shall prepare a register for said Annual Meeting and Election which shall include all persons who shall have presented themselves personally for registration for any annual budget vote and election or special district meeting or election and who shall have voted at any Annual or Special Meeting or Election conducted at any time during the 2014; 2015, 2016 and 2017 calendar years.

NOTICE IS GIVEN that Personal Registration may be achieved on any day, Monday through Friday, 8:00 a.m. to 2:00 p.m. prevailing time at the Eldred Central School District Office, 600 State Route 55, Eldred, New York up until Thursday, May 10, 2018.

NOTICE IS GIVEN: that the register of the district, so prepared, will be filed in the office of the School District Clerk at the Eldred CSD District Office, 600 State Route 55, Eldred, N.Y., where the same shall be open for inspection by any qualified voter of the district on each of the five (5) days prior to the Annual Meeting and Election, weekdays between the hours of 8:00 a.m. to 2:00 p.m., prevailing time. Said register will be open for inspection at the Eldred Junior/Senior High School, 600 State Route 55, Eldred, N.Y. during the hours of the Annual Meeting and Election.

NOTICE IS GIVEN that the District Clerk shall be at the Annual Meeting and Election on Tuesday, May 15, 2018, at the Eldred Junior/Senior High School, 600 State Route 55, Eldred, N.Y., between the hours of 11:00 am and 9:00 pm, prevailing time, where and when the Annual Meeting and Election will be held for the purpose of preparing a register of the school district for meetings or elections held subsequent to such Annual Meeting and Election.

NOTICE IS GIVEN that applications for Absentee Ballots may be applied for at the Office of the District Clerk. If the ballot is to be mailed to the voter, the completed application must be received by the District Clerk no later than Monday, May 7th, 2018 at 3:00 p.m., prevailing time. If the ballot is to be delivered personally to the voter, the completed application must be received by the District Clerk no later than Monday, May 14th, 2018 at 3:00 p.m., prevailing time. Absentee Ballots must be received in the office of the District Clerk no later than 5:00 p.m. prevailing time on May 15, 2018.

Pursuant to the provisions of Section 2018-a of the Education Law, qualified voters who meet the criteria for “permanently disabled” and are so certified by the Sullivan County Board of Elections and/or Orange County Board of Elections, will receive paper ballots by mail. A list of all persons to whom Absentee Ballots shall have been issued will be available for public inspection in the office of the District Clerk on each of the five (5) days prior to the date of the Annual Meeting and Election, weekdays between the hours of 8:00 a.m. and 2:00 p.m., prevailing time, and such list will also be posted at the polling place at the Annual Meeting and Election of members of the Board of Education.
