CONTRACT FOR HEALTH SERVICES

THIS AGREEMENT made in duplicate this 20th day of February 2017, by and between the Board of Education of ELDRED CENTRAL SCHOOL DISTRICT, in the County of Sullivan, State of New York, party of the first part and the Board of Education of the Valley Central School District of the towns of Montgomery, Wallkill, Crawford, Hamptonburgh, Newburgh, and New Windsor in the County of Orange, and the town of Shawangunk in the County of Ulster, party of the second part.

WITNESSETH, that whereas party of the first part being duly empowered under the provisions of Section 912 of the Education Law to enter into a contract for the purpose of providing health services for students residing in said school district and attending non-public schools in the Valley Central School District of the towns of Montgomery, Wallkill, Crawford, Hamptonburgh, Newburgh, and New Windsor in the County of Orange, and the town of Shawangunk in the County of Ulster, State of New York, for the school year beginning September 2, 2016 and ending June 23, 2017.

NOW, THEREFORE, the said party of the first part agrees to pay to the party of the second part the sum of **\$1107.95** for health services provided under Section 912 to approximately **1** student(s) residing in said **ELDRED CENTRAL SCHOOL DISTRICT** and attending non-public schools in the Valley Central School District.






